SECTION ONE

LIABILITY, LOSS OR DAMAGE: Indemnitor undertakes to indemnify Indemnitee from any and all liability, loss or damage Indemnitor may suffer during the duration of this agreement as a result of claim, demands, costs or judgments against Indemnitee arising from the conduct or management of, or from any work or anything whatsoever done on or about the premises described herein or any building or structure thereon or the equipment thereof or arising from any spaces therein or appurtenant thereto, o arising from ay act or negligence of Indemnitee or any of its agents, contractors or employees, or arising from any accident, injury or damage whatsoever, however caused, to any person or persons, or to the property of any person o persons occurring on, in, or about the premises or in any way whatsoever related to the conduct of the Hawaii Big Game Fishing Club's Frank Costanza Memorial Juniors' Fishing Tournament, and from and against all costs, attorney fees, expenses and liabilities incurred in or about any such claim or any action or proceeding brought thereon.

FRANK COSTANZO'S MEMORIAL JUNIORS TOURNAMENT 2008 INFORMATION SHEET AND RULES

1. Teams will be sponsored by local merchants of the community. The Entry Fee will be \$350.00 per team. The sponsoring merchant can supply one or more of their own teams, or HBGFC will help in finding teams and will keep the sponsor advised. Team sponsors will be contacted by HBGFC board member who will answer all questions regarding the sponsor's participation. A private boat (non-charter) must have its own team and sponsor. Entry fee is \$350.00 per team.
2. At least one adult from each team will work with the HBGFC board of directors (as volunteer) in working out the details of the tournament. That volunteer will attend the club's board meetings leading up to the tournament. It is the responsibility of the team to advise Kay Kolt of the name and phone number of the teams' adult volunteer.
3. Team members' parents must sign the "Disclaimer Form" on or before registration day. (Before the team starts fishing). No angler will be allowed to fish unless the "Disclaimer Form" is signed.
4. Briefing and Registration will be at the Hawaii Big Game Fishing Clubhouse on the afternoon of Friday, November 14, 2008. The teams draw for boats will take place at that time. All tournament paperwork must be completed and brought to the registration. A parent of each team (or team member) must be present at the briefing. **Saturday, November 14, 2008.** Fishing time will be from 8:00am to 3:00pm. Awards banquet will be at the Hawaii Big Game Fishing Clubhouse at 5:00pm. Skippers and Crewmen may accompany the teams to the banquet. Potluck items are welcome.
5. On the tournament day, any captain and crew that participate will be sure that no alcoholic beverages are consumed on the boat.
6. **No adults**, other than the captain and one (1) deckhand will be allowed aboard any vessel that is part of the boat draw. This includes friends, parents, guardians or observers, without special permission by the board, which will exercise discretion in special cases.
7. Participating teams should arrive either at their designated boat or at the HBGFC by 7:00am on Saturday, November 15, 2008 with their own lunches- READY TO GO!
8. Weigh-ins will be held at the Honokohau Fuel Dock.
9. Shortnose spearfish will be included in the marlin division.
10. 1st, 2nd and 3rd place awards will be presented for the three largest fish caught for each of the Four Flag Fish, Ahi, Marlin, Ono and Mahimahi and a 1st place award for the biggest Aku.
11. The tournament will be limited to a maximum of 20 teams in the draw of juniors 8 through 17 years of age.
